2. Why did you choose the college, university or technical school you plan to attend in the fall of 2012?
3. Enclose an official copy of your most recent high school grade transcript.
4. Enclose a copy of your SAT or ACT scores.
5. Briefly explain why you would be a good recipient of a PPL Montana Family Scholarship.
6. Enclose two letters of recommendation from non-relatives who can attest to your academic and personal achievements and abilities. Each letter should include the person's name, occupation (if appropriate) and relationship to you.
  - A: One letter must be from a teacher or a high school counselor.
  - B: One letter must be a personal reference from a non-relative who is NOT a teacher or a counselor.
